**(Share Repurchases in accordance with the Articles of Incorporation pursuant to paragraph 2, Article 165 of the Companies Act)**

Nippon Electric Glass Co., Ltd. (the “Company”) is pleased to announce that, at the Board of Directors meeting held today, its Board of Directors resolved to repurchase the Company’s own shares in accordance with Article 156 of the Companies Act applicable pursuant to paragraph 3, Article 165 of the Act, as follows.

**1. Reason for the share repurchases**

To enhance shareholder returns as a fruit of Medium-term Business Plan, “EGP2021”

**2. Details of the share repurchase program**

- (1) Type of shares to be repurchased: Common shares of the Company
- (2) Total number of shares to be repurchased: Up to 5 million shares  
(This number represents 5.17% of total outstanding shares excluding treasury stock)
- (3) Total repurchase amount: Up to 10 billion yen
- (4) Repurchase period: From October 1, 2021 to December 30, 2021
- (5) Repurchase method: Repurchase by means of market trades on the Tokyo Stock Exchange
